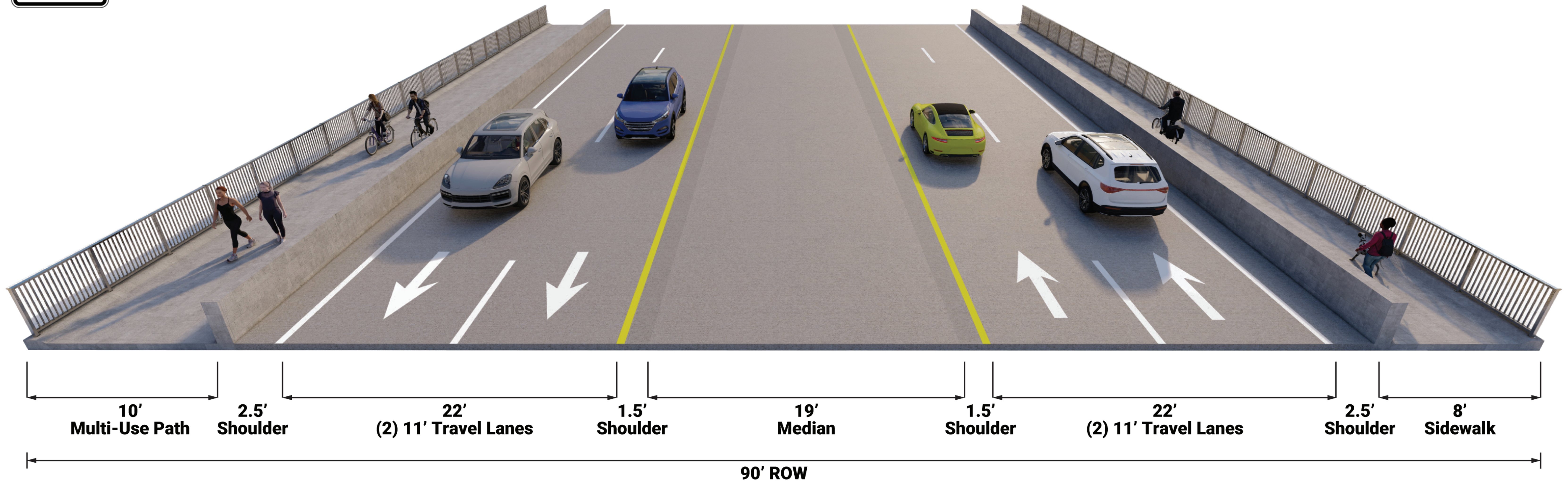

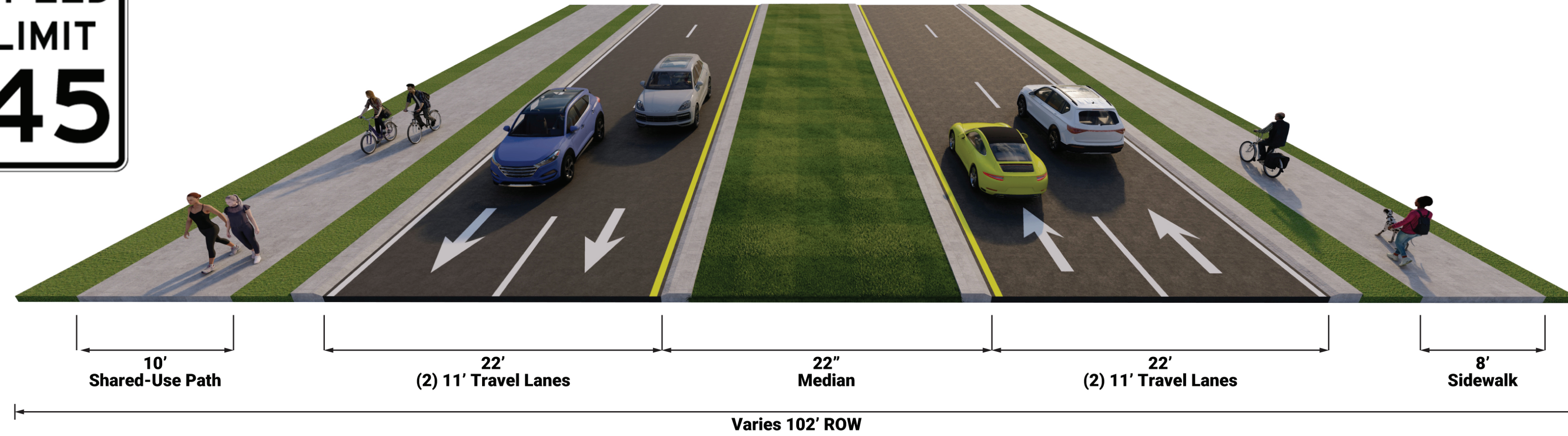
# PREFERRED TYPICAL SECTIONS



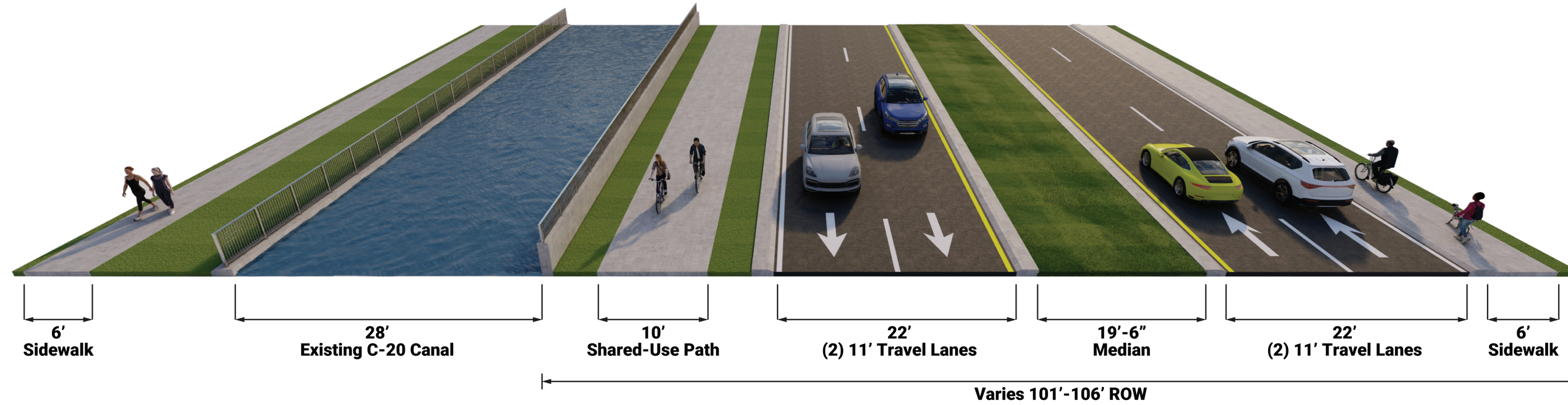
Preferred Alternative – Canal C-10 Bridge



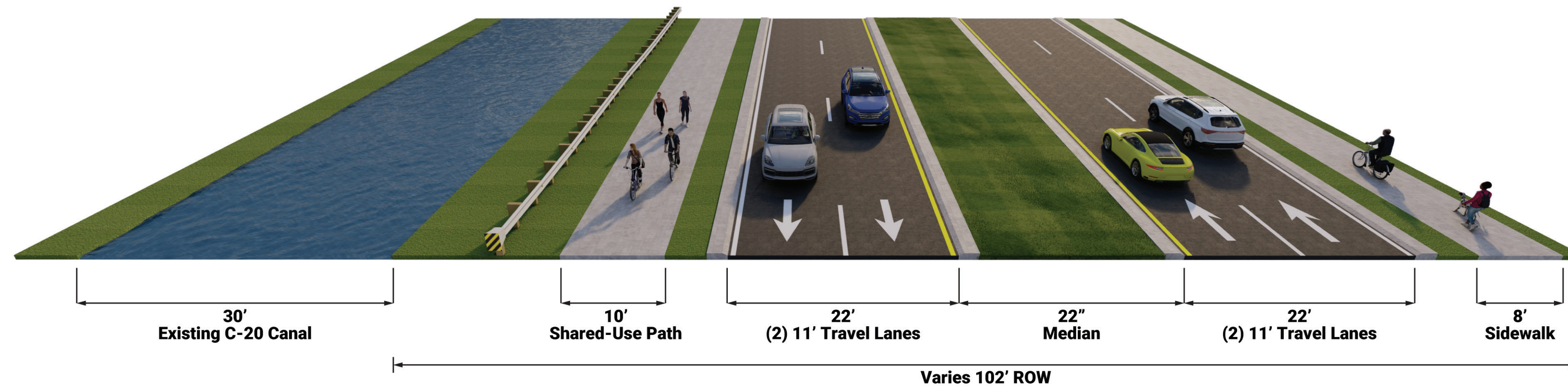
## PREFERRED TYPICAL SECTIONS
